Conditions

I/we hereby declare and certify that I am/we are the owner(s) of the horse(s) identified in the submission or, in the case of a stable name, multiple ownership or estate, that I am/we are owner(s) included in the stable or multiple ownership or the executor(s) of the estate and authorized on behalf of the stable, multiple ownership or estate to make this declaration and to consent to the terms set out below.

If this transfer of trainer is approved by the Judges or Stewards, I/we consent to the following terms to my/our licence(s) or to the licence of the stable name, multiple ownership or estate:

- a) The horses identified in the submission shall be stabled and trained only on premises to which Commission Officials and Investigators have unimpeded access to carry out any inspection or investigation that is provided for under the *Rules of Racing* or the *Horse Racing Licence Act*, 2015, including any inspection or investigation that may be necessary to monitor compliance to the Judges' or Stewards' approval of the transfer,
- b) I/we will provide or cause to be provided within the time periods specified by a Commission Official or Investigator any information, documents or other materials related to the training or care of the horses identified in submission that may be required by the Commission Official or Investigator,

- c) None of the horses listed in the application owned by me/us, the stable name, multiple ownership or estate, as the case may be, trained by the proposed Trainer of Record once this transfer is approved shall be transferred to or trained by another trainer without the approval of the Judges or Stewards,
- d) I/we will comply with or cause to be complied with any condition of the Judges' or Stewards' approval,
- e) The horses identified in the submission will be ineligible for entry or racing in Ontario if:
 - (i) a Commission Official or Investigator is unable to conduct any inspection or investigation where a horse is stabled or trained.
 - (ii) any person whose licence is suspended or who is not licensed provides goods or services for which a licence is required with respect to a horse identified in submission,
 - (iii) the information, documents or other materials required by the Commission Official or Investigator within the time period specified is not provided,
 - (iv) a horse is transferred to or trained by another trainer, or
 - (v) the conditions of the Judges' or Stewards' approval are not complied with.

By affixing your signature below, you will be deemed to have read and consented to the above conditions.
