Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

12:50 – Received a report from the Veterinarians office that the Lasix technicians missed treating Trainer Paula Loescher's horse "Comedy Gold" slated to compete in todays' first race. We then received a call from Paula who was quite upset because her horse did not receive the Lasix and now has to be scratched. Complained that she already pre-raced the horse and has to call and let the Owner know. We received a report from the Racing Forensics technician Megan McGirr who stated the printing system was down and everything had to be done by hand today and the horse "Comedy Gold" was overlooked. Mr. Richard Tso of Racing Forensics was contacted.

13:30 – Foal papers not available the horse "Winstanley" slated to compete in todays' third race. Horse has run here before and will run on a photo copy. Any purse money earned will be held until such time as the original Foal Certificate arrives in the Fort Erie race office.

Film Reviews:

Review of Sundays' third race involving Melanie Pinto and Pierre Mailhot for interference midstretch. Pierre said he had trouble breathing and his horse stepped out on him and into Melanie's horse, I was pretty weak and couldn't get him off her real quick. Melanie said her horse was full of run and he came out to me and moved my horse, stopped my momentum. Don't feel he did much to get his horse off me. After review we levied a one day suspension to Pierre. After review with the riders, Trainer By Raghunath who had requested to view the video attended and was given

the opportunity. He has requested a notice of Appeal.

After race 7 Ademar Santos attended the stand to review the third race from today for using his crop excessively. Ademar watched the video and could see the infraction, said he didn't mean to and was in the heat of battle. Said he needs to change his style and will do his best. He was advise the next violation will command a stiffer penalty. He was levied a \$300.00 monetary penalty and a day suspension.
