Senior Racing Official Dave Stewart in earlier today.

Jockey Agent Jordan Miller attended and enquired that Apprentice Jockey Kazushi Kimura would be eligible to carry a crop as he will have ridden the required five mounts prior to asking permission. His fifth lifetime mount is in the fourth race and he has mounts in the sixth and seventh races tonight. Mr. Kimura is required to call us following his fifth mount for permission. Investigations conducted vehicle searches this morning at Woodbine backstretch east gate. Trainer Stephen Owens (119930) was found to have unlabelled medication and a syringe in his vehicle. Report is to follow.

Jockey Chris Husbands excused off his mounts today.

Following the fourth race Apprentice Jockey Kazushi Kimura requested he be permitted to carry a crop as he has now ridden five mounts. Request granted. Mr. Kimura was tutored on the urging policy here in Ontario. The change was announced to the wagering public.
