#### Backstretch:

Call from Assistant Trainer Martha Gonzalez, the horse in the 4th race today "Classic Daniel" was found to have been loose from his stall last night and they are not comfortable having the horse compete today as they do not know if the horse may have gotten into some other feed in the barn. The horse was excused as a Stewards' scratch.

Security Supervisor, Robert Jordan attended to inform us that Groom Codi Capi (130849) has been issued a property trespass for conduct. Mr. Capi was to be placed on conditions with Woodbine having had a property trespass issued by Fort Erie Race Track last year. Incident report 2018-06-00051 was provided.

Jockey Agent Steven Roberts attended to inform us that Chris Husbands will be off his mounts today.

Trainer Anthony Pottinger attended. Informed that the horse "Saran Is Awesome", owned by Phillip Budhoo has been placed on the Stewards list and is ineligible to enter or race in the Province of Ontario. "Saran is Awesome" was to compete in the fourth race Wednesday June 6, 2018 but refused to go forward to post and was subsequently scratched by the Stewards. The Course Marshall had previously reported that this horse was fractious and would not go forward during training hours.

Call from Owner/Groom Judith Adams, issue concerning the horse Man Crush. Has had possession of the horse since September 2017. The previous owner has refused to forward the foal certificate to her. She bought the horse from him for a \$1.00 purchase price. We will look into the issue. The previous trainer is listed as Pat Parente. Spoke with Mr. Parente, the previous owner has some reservations about the health and welfare of the horse and requested a written assurance from a veterinarian as to the horses' status. We will have a veterinarian look into the matter and provide some information regarding the horse.
