Race 1 – #1 One Dashing Diva (Norman Lloyd DeSouza) broke slow from the gate. Race All Clear.

Race 4 – #1 Flirt With the Boyz (Tony Phillips) broke in the air. Race All Clear.

Race 7 - TCOF - #6 By Royal Appointment (Max Badal) on #5 You Zee Me Now

(Tyler Slater) and #7 Sparka Winning Shake (Neil Husbands) at the start. The video shows that #5 breaks out into #6 and causes Badal to check his horse. It also forces #6 into the backend of #7. #5 held at fault as he made the initial contact. #5 finished 9th and placed 10th.

- Jockey Tyler Slater was given a verbal caution for striking his mount more than three times in succession.

Race 8 – JCOF – #4 Deception North (Chelsey Willick) on #5 Zoomn Blue (Cory Spataro) and TCOF – #6 One Dashin Folly (Cassandra Jeschke) on #7 Kazoomin (Max Badal).

- The video shows where #7 is on the outside of horses and does keep open room between #6 and #7. All 4 horses do become closer as the race progresses; however, the video does not support #7 being held at fault. #5 is advancing between horses and tries to hold his position between #4 and #6. The racing does get tight between #4, #5 and #6, but the video does not show any sole horse being held responsible. #2 Grande Larceny (Brian Bell) is ahead and clear of #4 and #5 and as those horses continue to gain ground, Willick does have to check her horse. The Panel ruled there was insufficient video evidence to warrant any placings and both COFs were disallowed.

- #3 Not Whistlin Dixie (Tony Phillips) was a vet scratch at the gate. Refund \$806.

Race 9 – TCOF – #2 Dinahlicious (Ramiro Sanchez Castillo) on #3 Channelislandsflyer (Tony Phillips) and JCOF – #6 Itsallaboutramblin (Corrine Andros) on #7 Senator Woot (Brian Bell).

- TCOF #2 breaks slow out of the gate and as a result #1 Eyesa Wild Boy (Norman Lloyd DeSouza) and #3 fill the gap left by #2. Jockey Castillo said he had no problems and it was his horse breaking slow. TCOF disallowed.
- JCOF The video shows #7 is clear of #6 and does not cause any interference. JCOF disallowed.
