Race 1 – Stew's Inquiry & JCOF X 2 – #3 Ocean Dinastia (Tyler Slater) on #2 Six Figure Return (Cassandra Jeschke) and #4 Fabulous Dynasty (Ed Walton) on #1 Teller A Secret (Ramiro Sanchez Castillo). The video shows that #1 broke outward from the gate and comes across the track, causing interference to the three outside horses. #1 was found at fault; finished 5th and was placed 7th for causing interference to #s 2, 3 and 4. NOR for Castillo.

Race 2 - All Clear

- #2 You Zee Me Now (Tyler Slater) broke outward.

Race 3 – Ontario Sires Stakes Derby Trials, Timer check OK. Stew's Inquiry & JCOF X 2 & TCOF X 2

- JCOF #4 Eyesa Really Quick (Brian Bell) on #5 Caraways Jet Moon (Corrine Andros) & #5 on #7 Slingin Piston Annie (Tony Phillips).
- TCOF #4 on #5 & #6 Zoomin Special Angel (Ramiro Sanchez Castillo) on #7.
- The video shows that #7 does come down on the inside horses and causes tight racing amongst them. The Jockeys of #s 4, 5 and 6 all check their horses. #7 was not clear of the inside horses when crossing over and was deemed at fault for the interference. As a result, #7 finished 3rd and was placed 7th for causing interference to #s 4, 5, and 6. NOR for Phillips.

The video shows that #7 does come down, as #5 goes out slightly; however, the pan shot shows #7 is clear of #5 when crossing over. The Panel ruled that the video does not support a placing of #7 for causing interference. JCOF disallowed.
