Races:

Race 1, #3 Hardy Chuckle was fractious in the gate, was backed out by Commission Veterinarian

and checked, given clearance and re-loaded. #3 was off slow and trailed. Spoke with Jockey Jefferey Alderson, horse did not hit his head in the gate but had no early speed. Did close ground through stretch. Rest good.

Race 2, #7 Weed Be Happy, hesitated and popped up at start, outrun early, closed late. Rest good.

Race 3, Turf, clear

Race 4, clear, turf upgraded to Firm

Race 5, Turf, Stewards' Inquiry, #1 Harper PM, 5th, R. Hernandez and #8 Chill, 2nd, L. Contreras, top of stretch and through stretch. Upon review of the upper pan and front tower camera angles, speaking with the riders involved. Contreras felt he moved out a little as his horse switched leads, but was clear. Hernandez stated he was just getting in motion and had to change course. This appeared to happen again mid-stretch and the Stewards felt the interference was sufficient to hinder #1's position at the finish and disqualified #8 from 2nd to 5th for interference.

Race 8, #3 Alkeline hesitated at the start, rest ok

Race 9, Turf, Wonder Where Stakes, reviewed run around the far turn regarding #3 Double Latte and #5 Glamnation, Spoke with Chantal Sutherland, #3, she explained #5 was not at fault as the outside horses went by quickly and #5 reacted to it down to her horse and it got tight on the rail. No inquiry required.
