and #4 Yournotthebossofme (Chelsey Willick). The front tower shows that #4 does come down; however, the pan shot shows that #4 is clear and does not support a placing of #4. The Panel ruled there was insufficient video evidence to warrant a placing.

Race 4 – Inquiry – Reviewed the start of #6 Charted by DM (Corrine Andros). The gate of #6 does open later than the other gates. The horse did have a flipping halter that may have contributed to the situation. The Panel ruled #6 received an unfair start and was refunded. Refund \$1,105.

- #2 Georgies May Kitty (Ramiro Sanchez Castillo) broke outward. #4 Arising Miracle (Corrine Andros) broke slow from the gate.

Race 7 – Stew's Inquiry & TCOF after the start.

- Inquiry Reviewed the break between #7 Peepl R Krazi (Nakia Ramirez), #8 Its Sweet Tobe First (Ed Walton) and #9 Far Side Of The Moon (Brian Bell). The front tower shows that #9 breaks inward into #8 and hits that horse to force it into the back end of #7. The Panel ruled that #9 initiated the contact and caused interference to #8. #9 finished 3rd and was placed 10th.
- TCOF #2 Jrs Painted Dancer (Cory Spataro) on #1 Sr Solid Rubi (Ramiro Sanchez Castillo). #1 steps out at the start and initiates contact with #2. Both horses run a little erratic after the start. Jockey Castillo stated he had no problem and the video does not support disqualifying #2 for interference. TCOF disallowed.
