Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

09:05 - Received a call from Assistant Trainer Nolan Ramsey to explain he entered the horse "Hemp Hemp Hurray" in tomorrows' Ontario Jockey Club Stakes and forgot to enter with blinkers on. We advised that any equipment change is required to be denoted on the entry slip and therefore the change is not possible at this time. We also relayed to Mr. Ramsey there is a dispute being lodged by Trainer Gail Cox that she had first call with Jockey Gary Boulanger to rider her horse "Malibu Uproar" in todays' eleventh race and was spun at the draw. She had relayed earlier that she gave the call to Gary shortly after the condition book came out approximately August 6 or 7. Mr. Ramsey explained agent Gary Kemplin gave him the call to ride his horse "Pawnbroker" on August 21 and then approached me last week and asked that I let him off as he may have a problem, said he wouldn't let him off as he has done this to him before. Advised we are to have a review with Gary and Gail later this morning to resolve the matter. Gail attended however, Mr. Kemplin did not answer our page or call to his cell phone. We determined Ms. Cox did have the call and have ordered that Boulanger rider her horse.

09:55 - Owner Bob Foster attended to say he requires a Bill of Sale so he may buy his partner out. We furnished him with the document and explained how it should be completed.
