

- Review with driver Kyle Forgie regarding his urging in the stretch from race 10 at Kawartha on 25 August. Mr. Forgie is now aware of what is considered permissible urging and of the penalty for any violation of the urging regulations, no penalty.
- CAVIART SUNDANCE (Matt McDonald trainer) was a Judges (other) scratch from the 8th race as this horse was administered Lasix outside of the prescribed time (AGCO rule 35.07.01).

- 1. Reviewed break by #5 TOPVILLE CHROME (Gilles Gendron) after the 3/4 mile pole, #5 did cause interference to #6 ROSE RUN RANGER (Jonathan Lachance) (charted with interference), no placing necessary as #5 finished 6<sup>th</sup> (last). Driver of #2 BEACH BOY, Guy Gagnon, adjudged guilty of violating AGCO rule 22.05.01 (k) (failure to set or maintain a pace comparable to class) in the second guarter (28<sup>1</sup> 58<sup>3</sup> 126<sup>4</sup> 154<sup>4</sup>) and assessed a monetary penalty of \$100 (SB 50913).
