Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

- 09:30 Owner Tony Gaito called for information on a protest his trainer lodged at Fort Erie a week ago. It was explained to Mr. Gaito the process and he needs to contact the Fort Erie board of Stewards as they are handling his protest.
- 10:05 Trainer John Leblanc attended to complain that Jockey Agent Jordan Miller gave him a call for his horse "Moka Latte" in this Sundays last race and then called him at entry time to say he didn't realize trainer Julie Belhumeur was going into the race and has to ride her horse. John said he had Simon Husbands work the horse and Simon told him after that his agent shouldn't have given him the call as we already had a call with Julie. We spoke to Simon who explained his agent made a mistake and named me on two horses. Contacted Jordan to attend our office.
- 11:10 Jockey Agent Jordan Miller attended to explain that he erred in that he thought Julie was going into another race. Monetary penalty of \$100.00
- 11:15 Race office reported that in today's ninth race, the foal certificate of #1 "Siding Spring" is not in the office, however, as the horse has run here before, it will run on a photo copy today. Any purse money realized will be held until such time as the papers are delivered.

Film Reviews:

Review of fourth race from Wednesday September 26 with Juan Crawford, Kirk Johnson and Diasuke Fukumoto. Juan said of incident one, going into the turn, that he had Rafael on his outside holding his ground when the inside horse with Diasuke aboard tipped out from the inside forcing him out and into the hind end of Rafael. Put me in a bad spot.

The second incident involving Juan and Kirk Johnson, Kirk said he was on a first timer on the fence when Juan went by him and squeezed him out, almost went over the fence. Juan said his horse was shook up from the first incident and I was just trying to get around there. The seven horse was outside of me guiding me down and onto Kirk.

After deliberation it was decided that both Diasuke and Juan be levied three day riding suspensions.
