Review of yesterdays' eleventh race involving Kazushi Kimura. Said he might have cut it a bit fine but also felt that when he made his move Daisuke stepped out at the same time.

Claim of her horse "Lilly's Answer" from the second race Friday September 28, 2018. Contacted Trainer Don MacRae to advise him of the protest and that the horse would be placed on the Stewards' List until an investigation is complete.

Race 3 – Clear, following the race we received a call from Kevin Diamond who submitted a claim for the horse "Distinct Passion". He questioned why the claim was voided. We explained that he denoted on the Claim Slip that it was an Initial Claim but the document was not included in the envelope. The Initial Claim must accompany the Claim Slip to be valid. Received a complaint from Trainer Harold Ladouceur about his Jockey Simon Husbands, didn't feel he rode his horse well. Reviewed the race and spoke with Mr. Husbands and found nothing untoward.

Race 4 – Jesse Campbell aboard #4 "Staightfromegbert" steadied inside the seventy yard pole. Heading for a hole that started to close just before he got there. Spoke to Jesse who said Diasuke came over a bit but he anticipated Diasuke closing the door which never happened.
