Race 1, #4 Too Much White, 5th and #3 Bending Over, 3rd, off a step slow. On review of the start in slow motion regarding #4, the stall doors of the gate appear to open a little slow. Does not hinder the start of the horse.

Race 2, Time check completed. Picov Derby Trials, Stewards' Inquiry, start regarding #4 Elenorr, upon review, the stall doors of the #4 do open later than the rest. The horse is on a flipping halter and may have pulled back on the doors at the time the starter dispatched the field. A complete refund of #4 was ordered due to an unfair start. Total refund of \$3621.

Race 3, Timer check completed, Picov Derby Trials, clear

Race 4, clear

Race 5, Stewards' inquiry regarding #1, Dash to Miami, T. Phillips, 3rd and #3 You Zee Me Now, T. Slater, 5th approaching the finish. Upon review with the front tower and upper pan camera angles, #1 appears to be lugging out as T. Phillips is trying to correct his mount with right handed urging. The #1 goes out to #1 nearing the finish and they make contact. T. Slater has to check and fades back to 5th. #1 was 3rd placed 5th for interference. Race 6, #6 Not Whistlin Dixie, 1st, Bore out at start, rest good.

Race 7, #6 Just Call Me Stoli popped up at start, some incidental bumping at the start with #1, #2, #3 and #4

Race 8, clear, front tower camera angle was disturbed and broken up for a portion of the race, utilized the pan shot

Race 9, Jockey claim of foul, #4 Max Badal, 7th on #3 B. Bell, 2nd at the start. Upon review, front tower and upper pan camera angles, #6 bares in at the start into #5 and down to #4, #4 is a step slow and its start is compromised, the #3 breaks in front of #4.
