Backstretch:

Trainer Howard Keen attended, signed bill of sale for the horse Showing Sin, is now sole owner.

Owner/Trainer Salvatore Meli attended and provided a bill of sale for the horse Past Curfew, is now sole owner.

Racing Manager Mike Wilson and Senior Advisor Strategic Engagement, Jennifer Iveson and Manager of Strategic Policy, Katie Cunningham from AGCO attended to discuss concussion protocol with race Officials in the backstretch and in the jockey quarters as well.

Following the 1st race, Official veterinarians reported #3 Major Gordon had bled. Trainer John Ross was informed that Major Gordon is ineligible to race in the Province of Ontario for fourteen days, through October 30, 2018 as per TB Ruling #10988

Following the second race, Clerk of Scales informed us that he could secure a rider for Victoria Place in the 5th race. Trainer H. Keen was notified and the horse was a Stewards scratch. Following the third race the Clerk of Scales informed us that he could not secure a rider for #4 Christie Pitts in the 7th race. Christie Pitts was a Stewards' scratch.
