Race 6 – Stewards Inquiry and Jockey Claim of Foul (COF) by Steven Bahen aboard #11 "Fort of Luxury" against #9 "Peut Etre" ridden by Kazushi Kimura for interference mid-stretch. Steve said he came out into me, just drove out into my path and everyone else to my outside. Kazushi said

his horse went out with him under left handed urging but thought he kept pretty straight. Sheena Ryan who was aboard #8 "Pottahawk" said she was in between and Kazushi came out with his horse and got several of us. Eurico Da Silva aboard #5 "Marner" said it was bad but didn't claim foul on Kazushi because he finished so far back. Spoke with Jerome Lermyte aboard #10 "Queen of the North" who was on the outside, said he came in a bit but straightened, pressure was from the inside. After review, we disqualified Kazushi's mount #9 from second position and placed him ninth behind Eurico's mount #5.

Gary said he had his head down riding and they brushed a bit but not sure it effected my horse much. Kazushi said he thought he kept pretty straight, we were riding tight together for the wire. After review, the COF was disallowed. No change
