Backstretch:

09:05 - Jockey Agent Ron Burke attended to say his rider Slade Callaghan is unable to stay for todays last race and has spoken with Trainer Greg Cox, Kirk Johnson will ride in his place.

Film Reviews:

Yesterdays' sixth race with participants Kazushi Kimura, Steven Bahen, Sheena Ryan, Eurico Da Silva and Jerome Lermyte. Steven said Kazushi hit his horse left handed and the horse went out with him and into our path, continued to hit left, should have pulled off. Sheena said she was next to Eurico and they were strongly interfered with. Kazushi said he hit his horse left handed and he went out with me, could have done better to keep straight. Three day suspension levied against Kazush. Further discussion with Eurico Da Silva for failure to claim foul. \$200 monetary penalty.

Tenth race involving Kazushi Kimura and Rafael Hernandez. Rafael said Kazushi should have waited another stride or two before tipping out, or could have stayed his course and follow Eurico through on the fence. Kazushi said he did go out on Rafael but straightened as quickly as he could but damage was done. No action taken.

Said she was out of horse and just trying to keep her horse straight, Rafael was already by her. COF disallowed. #2 "Another Time" ridden by Patrick Husbands was away slow.
