

The horses that he had scratched in the US are not eligible to be claimed.

## Races

R1-Inquiry after the 3/4. #4 Wray (6th) bears in and hooks wheels with #7 Richardson (2<sup>nd</sup>) and causes #2 Steward (3<sup>rd</sup>) to jerk away and go off stride. Interference suffered by several other horses. #4 Randy Cam finished 6th and placed 7th for causing interference. No penalty applied to Wray horse at fault.
