9:00 – Jockey agent Steve Roberts attended to say that Trainer Earl Barnett had given him a call and did not honour it. Spoke with Trainer Barnett who claims he never gave a call to Steve and that he gave the call to Jockey Agent Mike Luider the day after the horse ran for his rider Eurico Da Silva. Spoke with Jockey Agent Mike Luider who relayed he was given the call the next day after the horse ran. Steve Roberts attended later in the morning to say he would like to pursue the issue further. Explained we would get the two together tomorrow.

9:15 – Jockey agent Ken Zweig attended to say he jumped on a horse for Trainer Jim Ensom as per his permission but he wants Jockey Hernandez. Spoke to Mr. Ensom who said there is a misunderstanding, said Mr. Zweig could jump on horses I own but not for other owners I train for. We made the change to Hernandez and took no action against Mr. Zweig.

Jockey Sunny Singh excused from his mount in the 10<sup>th</sup> race today.

#### Film Reviews:

Review of Wednesday evening race three involving Jockey Christopher Husbands for inadvertently striking another horse during the stretch run.

## Races:

Race 1 – #6 "Mad Slam" ridden by Jesse Campbell was away slow. #5 "I'll Take the Gold" ridden by Skye Chernetz broke out, filling the void.

Race 2 – Stewards' Inquiry into the stretch run regarding #3 "Miss Forester" ridden by Steven Bahen and #7 "M Cantata" ridden by Rafael Hernandez. Steven said he thought he was going by Rafael but he kept coming out, couldn't get by him and couldn't get back off him. Put me in a bad spot but I could see his horse was on one line. Rafael said the horse was getting out bad and only had a "D" bit on. Did my best to keep him straight. After review we disqualified Rafael's mount from third and placed him fifth behind Steve's mount.
