Luis said he felt he kept straight and I may have been Emma who came out through the stretch. Emma said her horse was drifting out a bit but never interfered with Rafael, thought the outside horse may have stepped in late but they were by Rafael. Rafael relayed the two started coming together and he was still up in there. Horses do start to close the hole late but not completely and they have passed him at that point. After review the COF was disallowed.
