Very cold temperatures forecast for tonight's card of racing. Will be monitoring extreme temperature values for all involved.

Concerns from a couple of trainers regarding shortened post times between races due to the cold temperatures and a short delay for the second race, resulted in horses in later races arriving in the paddock at 14-13 minutes to post invalidating any claims submitted later than 15 minutes as per TB Rule 12.11. Director of TB racing Steve Lym was aware of the situation.
