Report on day's events:

Office:

- Trainer Francis Guillemette adjudged guilty of violating AGCO rule 17.17 by withdrawing CLEVER THING from the 12th race without the permission of the Judges and assessed a monetary penalty of \$100 (SB 50916). AGCO rule 15.06 applies, CLEVER THING may be claimed for \$7,000 in Ontario for 30 days.
