- Review with driver Jacques Beaudoin from 24 March race 8 #9 COLLECTOR CLASSIC regarding his urging in the stretch; explanation of Mr. Beaudoin was partially accepted and no penalty was assigned although a full explanation was provided as to urging expectations.
- Trainer Blake Curran adjudged guilty of violating AGCO rule 35.07.07 (did fail to bring CANADIAN EDITION to the retention facility within the prescribed time to receive Lasix causing this horse to be scratched from the 12th race) and assessed a monetary penalty of \$100; SB 50943.
