09:45 – Received a fax from the Pennsylvania racing commission regarding Owner/Trainer William Vito Armata regarding an outstanding fine due May 7, 2019. Spoke with Willie and advised he was to call the PA commission yesterday, to which he relayed he had not. We told that the ruling has him suspended as of yesterday if the fine had not been paid and he should contact them immediately and have them send us notice. If not received before scratch time, he would be deemed to be suspended and his horses entered would be scratched.
