Kazushi said his horse gets out and even training in the morning he is tough to gallop and usually has another horse to the outside to help him around the turns. Emma said she was in front of them and kept a straight course. Kirk said he was on the outside and his horse was getting out with him, not part of the incident. After deliberation we felt Kazushi's horse did take a step out but he had the horses head turned hard to the inside trying to maintain a straight course. No penalty was issued to Kazushi.
