We also received a call from Skye to say Justin did have the call and Mr. Lay just named her on, didn't know he was going in the race. We made the change to put Skye on the horse and Mr. Wilson was upset that we removed his rider after being listed in the program. Spoke to Justin Nixon and he was pleased with the outcome.

Jesse did feel however, that Kazushi on #1 "Salieri" got up inside him late. Kazushi said he let his horse go up along the rail but never came off it or bothered anyone. Rafael Hernandez aboard #2 "Executive Sight" was behind and to the outside and thought from his vantage point, Kazushi should not have run up the inside.
