### Film Reviews:

Review with Justin Stein and Michelle Rainford (represented by Irwin Driedger) for interference during the stretch run of the seventh race. Justin said he only hit the horse left handed a couple times and not sure if he saw something the same time I hit him when he ducked out. Didn't think it was much at first until I say the replay, then realized we moved that horse pretty good. In a written statement left by Michelle, she said she was running straight and my horse was running on when I was bumped from the inside hard, feel it cost me the win. After consultation we levied a three day suspension to Justin, days to be determined.

Review with Justin and Jeffrey Alderson for interference in the vicinity of the ½ mile pole in race eight, the Plate Trial Stakes. Jeffrey said he didn't realize Justin was inside until he yelled then took out to give him room. Justin said he was getting in there slowly but still had run to the turn, yelled and had to back out of there. After the review we decided no penalty was required.
