

## Races

Race 1 – Late Judges Scratch of #5 Mach Dynasty. Refund \$727. Race All Clear.

Race 2 – Reviewed the break by #6 Jimmy Wintips (Scott Wray) before the start, finished 5th. The horse was inside the Fair Start Pole and did not violate any of the breaking rules.

Race 3 – All Clear. #4 Gold Star Diablo (Travis Cullen) finished with broken equipment (overcheck).

Race 4 – Reviewed pylons on #4 Scottish Mach (Ryan Holliday) at the top of the stretch, finished 5<sup>th</sup>. The horse was inside two pylons and not lapped, no violations.

 +1 Classic Tina (Austin Sorrie) finished distanced and must qualify for Performance (17).

Race 5 – All Clear

Race 6 – Reviewed #8 Bunkhouse Brawl (Preston Shaw) going to the 3/4s, finished 2<sup>nd</sup> – horse got rough but did not make a break, no violations.

Race 7 – Reviewed pylons on #7 Fightyourobsession (James MacDonald) at the top of the stretch, finished 5<sup>th</sup>. The horse was inside two pylons and not lapped, no violations.

- Reviewed the break by #1 Windsun Lotus (Natasha Day) in the first turn — interference break to #3 Boots N Brian (Tony Kerwood). #2 Time For Wine (Dustin McClure), #4 Flying Solo (Austin Sorrie), #5 Sportscrazy (Ryan Holliday), #7, and #8 Vintage Gold (Scott Wray) were charted with interference. No placings needed. #1 did finish with broken equipment (knee boot).

Race 8 – Inquiry/Accident at the 5/8ths – #4 Dreamfair Helena (Drew Neil) makes a break and hooks wheels with #8 Mae Belle Duke (Ryan Holliday), which caused #4 to fall and unseat Neill. #1 Crankys Boy (Austin Sorrie), #5 Greystone Wisky O (James MacDonald), #6 Itaintezbeincheesy (Jason Ryan), and #8 all suffered interference. #5 pulled up at the top of the stretch and did not finish.

- Dr. Robson did check #4 Dreamfair Helena following the race and reported no injuries. EMS did clear driver Neill.
- Reviewed pylons on #2 Keen As A Bean (Trevor Henry), finished 2<sup>nd</sup> no violations.
- Reviewed racing in the first turn between #1 Crankys Boy (Austin Sorrie) and #8
  Mae Belle Duke (Ryan Holliday) no action needed.
- Driver breathalyzer retest race.

Race 9 – Inquiry – Reviewed pylons on #1 Asbraveasmymomma (Scott Wray) in the first turn, finished 3<sup>rd</sup>. The horse was inside three consecutive pylons. Wray felt he was pressured into the pylons by #4 Oldfriendskentucky (James MacDonald). The video does not support interference by #4 on #1. #1 finished 3<sup>rd</sup> and was placed 8<sup>th</sup> for a pylon violation (inside three consecutive pylons).

- Reviewed pylons on #4 after the half – no violations of the pylon rule.

Race 10 – Kin Pace Final. Reviewed racing in the first turn – #2 Twin B Friendly (Jason Ryan) makes a break and causes interference to #5 So Much More (Trevor Henry). No placings needed.
