Said the nebulizer with DMSO was meant for the horse in the next stall and was mistakenly used on "Victor's Flag". We advised this necessitates a scratch and carries a monetary penalty of \$300.00

Review of yesterdays' third race involving Leo Salles, Luis Contreras and Emma Wilson. Lteo explained he was inside Emma going into the turn when Luis' horse come out in front of him and he caught that ones' heels, happened fast. Emma and I were going around fine til that happened. Luis said his horse changed leads but just went straight out with him, didn't drop into the turn as he expected. Was slowing his horse up and it threw its head on me and went out, nothing I could do. Emma said she was outside Leo and heard him yelling at Luis and then he was gone. I didn't come in. Upon consideration of the facts, Luis Contreras is levied a three day riding suspension,

Race 2 – Rider Claim of Foul (COF) by Sunny Singh aboard #4 "Marvel" against #5 "Peut Etre" ridden by Kazushi Kimura for interference going into the clubhouse turn. Sunny said he was away slow but was getting up along the rail into the first turn when Kazushi came over a little too quick on him. Kazushi said he looked and saw #4 inside, made sure he was clear and moved forward. Never went to the fence and never bothered anyone. After review, the COF was disallowed.
