Emma said Boulangers' horse tipped out into the path of Stein who came out to me and I went into David. Gary said his horse was lugging in then switched leads and went out maybe half a lane but didn't think it amounted to much. Stein said Gary's horse came across in front of him which started a chain reaction. After review the COF #5 on #7 was disallowed, however, #2 "Dance Ready" with Boulanger aboard was disqualified from second and placed fifth behind #5 "Magique". #8 "Nordic Pearl" ridden by Simon Husbands was out distanced.
