Review of the seventh race from Friday September 6 with Omar Moreno and use of his crop when out of contention. This was considered an educational review as Omar has no prior violations.

Race 7 – Stewards Inquiry into an incident at the top of the stretch regarding #10 "Final Rhapsody" ridden by Eurico Da Silva. No change.

Race 10 – Stewards Inquiry and rider Claim of Foul (COF) by Eurico Da Silva aboard #1 "King Ottokar" against #5 "Silent Jet" ridden by Daisuke Fukumoto for interference through the stretch. Kazushi Kimura asked that we look at the run through the stretch regarding #1 and #5. Daisuke said his horse was drifting but never bothered or made contact with anyone. Eurico said Daisuke kept coming out and intimidated his horse, didn't think it was a fair race. Kazushi said they kept going out through the stretch, not sure who it was. We also spoke with Justin Stein who was aboard #3 "Gaultier" about earlier in the stretch and he explained Diasuke did come out but was just clear of him and he was not bothered by him. After review of the Pan and Head on shots, it is apparent Daisuke's mount does drift but never forces Eurico and always maintains a distance between the two, none of the riders has to check or stop riding at any point. Eurico and Diasuke do eventually come together with a solid contact, however, this happens past the finish line. COF was disallowed and there is no change to the order of finish.
