Race 1 Clear

Race 2 Inquiry in the stretch. #5 Remember This (S. Steacy) did bear out in the stretch and did cause an interference break to #6 Los Ballykeelamigo (Richardson). #5 finished 2nd and was placed 5th.

Driver Shawn Steacy assessed a 3 day driving penalty for causing interference. Sept 18 19 20 2019. Sb 51024.

Race 3 Clear. Terry Fritz was cautioned regarding his urging in the stretch.

Race 4 reviewed the breakers in the first turn. No violations. #7 Lifeisgood Hanover made a break before the 1/4 and did not finish. #5 on the Judges list and must

qualify. Also was examined by the track Vet and was placed on the short term list for lameness.

Race 5 Inquiry past the $\frac{1}{2}$. #4 Rockabilly Barbie (Holliday) was inside 2 consecutive pylons and was lapped on at the finish. #4 finished 2nd and placed 3rd. No penalty to the driver, the horse was visibly bearing in.

Race 6 Clear

Race 7 Reviewed the $\frac{3}{4}$ pole. #1 One Chilly night did bear out abruptly and caused interference to #5 Maddys Credit, no placing was required.

Race 8 Recall. Possible broken equipment before the start on #2 Mr Arch. #6 French Twist (O'Brian) did make an equipment break past the $\frac{1}{4}$ and pulled up (hopples).
