Lenoir Dubois, nominated horse to Overnight Stake for Saturday, Cypress Gardens, is not on nominated horse stake sheet. Will check with Stakes C-ordinator Julie Bell.

Jockey Agent Pram Seebah now representing 10 pound apprentice Jamal Mahone, has not been given permission to carry a crop as of yet.

Trainer Nick Nosowenko issued a monetary penalty in the amount of \$100.00 for failing to have the horse Dancing Doll in the paddock at the appointed time for the 4th race on Sept. 14, 2019.

Trainer Blair Miller assessed a monetary penalty of \$300.00 for a stable error necessitating a scratch of the horse Touch of Emma from the 4th race Sept. 14, 2019.

Daisuke Fukumoto apprenticeship has expired, attended and licensed as a Journeyman Jockey.

At 12:35, the Stewards were informed that Woodbine management had removed the 1st 3rd 4th and 10th races from the E. P. Taylor turf due to current weather conditions, rain.

Jockey Jamie Spencer reminded of urging policy here in Ontario.

Following the 4th race jockey Justin Stein was excused from his mount in the 11th race.

Film Reviews:

Race 9, Sept. 14/19

Luis Saez not available for review. We asked if John Velasquez, rep of jockey guild in the U.S.A., would review and we would be available if he had any comments on Mr. Saez's behalf. He intimated that he would be agreeable to any penalty issued.

Mr. Saez assessed a three day riding suspension for interference in the stretch run of the 9th race, Ricoh Woodbine Mile, approaching the finish resulting in a placing of 3rd to 4th and a monetary penalty of \$200.00 for an urging violation, excessive use of the crop as per TB Rule 9.27.05 (b)

Races:

Race 1, off E. P. Taylor turf, #4 Forest Brother bore out into far turn, was pulled up in the stretch and did not finish, rest ok. Spoke with Luis Contreras who stated that the horse was fine to middle of turn and then did not feel comfortable.

Race 2, clear

Race 3, off E. P. Taylor turf, clear

Race 4, off E. P. Taylor turf, #13 Delly off slow, #12 Just Bling It bore out into far turn and was eased through stretch appeared to be lugging out.

Race 5, clear

Race 6, Inner turf, Ontario Racing Stakes, #8 Divided Sky was off a step slow, rest good

Race 7, E. P. Taylor turf, Summer Stakes, #1 Vitalogy was off a step slow and in tight in stretch, rest ok. Jockey Jamie Spencer cited for an urging violation, hand above head height while urging. Issued a monetary penalty of \$500.00

Race 8, clear. Issue with the on-track system, utilized Woodbine broadcast feed.

Race 9, E. P. Taylor turf, Natalma Stakes, reviewed stretch run, #3 Fair Maiden, F. Prat, 3rd and #7 Secret Stash, J. Velasquez, 5th, #3 does drift out 2 paths under left handed urging as #7 is gaining some ground, J. Velasquez is riding full out and the #3 is clear at that point, no violations.
