Race 2 – Stewards Inquiry and Rider Claim of foul by Oscar Andrade Jr. aboard #3 "Sw Artemisia" against #1 "Sweet Night Fever" ridden by Cory Spataro for interference mid-stretch. Cory said his horse ducked out with him, not sure what he spooked from but it was quick and grabbed as quick as possible. Didn't think I bothered anyone. Oscar said #1 came out and moved him, lost some momentum and felt it cost him a position. After review we disqualified #1 from third and placed him fifth behind #3.

Race 3 – It was brought to our attention at five minutes to post that the Foal certificate for #9 has a tattoo 351F8, however the tattoo on the horse was 351F2. The Identifier relayed that all markings for the horse matched the foal certificate and the tattooist Mr. Slater who wrote the number on the certificate also identified the mistake. The papers should read as the tattoo on the horse and will be rectified. Claim of Foul (COF) by the trainer of #8 "Reach for It" against the winner #7 "Eazy Street" ridden by Tony Phillips for interference leaving the gate. Tony said the #8

broke slow and his horse did step out but felt the #8 hit his hind quarters, turning his horse out. Regan Knowles rider of #8 thought it was the #9 who crossed in front of him but did not claim foul. After review the COF was disallowed.
