

Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

Riders were not comfortable with using Lane 4 on the Inner Turf, feel there is not enough room. Said it may be a visual issue but feel it is too close to the outside fence. Races slated for the Inner Turf today were switched to Lane 1

Film Reviews:

In a follow up to yesterdays report. We held a review with Jockey Corey Jordan who rode "Hello Annie" in the second race Thursday June 25. Corey used his crop in an excessive manner, hitting his mount five times in succession twice during the stretch drive. After viewing the video, Corey had no explanation only to say he didn't realize what he had done until viewing the replay with us. Corey was issued a monetary penalty of \$200.00

Race 3 – We received an all clear from the riders and then Veterinarian Oscar Calvete called us to relay that Domenic Polsinelli the trainer of #4 "Cindervella" ridden by Luis Contreras, wished to lodge a Claim of Foul against #6 "Finding Perfection" ridden by Rafael Hernandez for interference in deep stretch. Rafael said he went by Luis and then it looked like Luis decided to take up and get his horse to the outside, said he never bothered Luis. Luis said he wanted to Claim foul but he didn't get far enough to speak to the person (Mark Ransom) who has the radio. Said his horse reacted to Rafaels' horse when it was coming over and had to take up and go to the outside. After review it appears Hernandez has already passed Luis when Luis checks up and pulls his horse to the outside. Claim of Foul was disallowed.

Race 4 – Stewards Inquiry at the start regarding #7 "Appella" ridden by David Moran and #6 "Classy Mistress" ridden by Justin Stein, also received a call from the Trainer of #6 Darwin Banach asking us to look at the start. Justin said he got ploughed pretty good first couple jumps, said the #7 pushed him two stalls at least to the inside. David said she just made a left with him first jump, tried to correct her as quick as possible but the damage was done. After review, we disqualified #7 from second placing that one sixth behind #6. We also reviewed an incident at the head of the stretch, involving Sunny Singh aboard #2 "Audition"
