Race 7, #11 Mr. Todd, J. Stein, was eased through the stretch. Spoke with J. Stein who stated that the horse seemed somewhat overheated and best interest to stop with him. Jockey Chris Douglas aboard #4Torah's Blessing, 7th, was observed to have used his crop in the overhand position through the stretch, issued a warning. Prior to the start, #1 Lookout Louie was fractious after loading in the gate, the Official Veterinarian ordered the horse to back out and observed the horse for any ailments and viewed it trot behind the gate. #1 was cleared to run.
