Race 1 – All Clear

Race 2 – Reviewed pylons on #4 Aneto (Jody Jamieson) in the stretch, finished 4<sup>th</sup> – the horse hit two pylons (not inside), no violations.

Race 5 – All Clear

Race 6 – Reviewed the stretch for a possible violation of AGCO Rule 22.05.01(e) by #1 Treacherous Reign (Bob McClure). McClure does attempt to correct his horse as she is visibly running out; no violation.

- McClure – \$500 monetary penalty – did fail to keep both feet in the stirrups. AGCO Rule 22.19 (third offence within six months). Ruling #1043449.

Race 7 – Inquiry – Reviewed racing in the stretch between #1 Sports Column (James MacDonald) and #2 East End (Jonathan Drury). The front tower video shows that #1 is bearing out slightly and #2 is bearing in slightly at the top of the stretch. As #2 takes the lead in deep stretch he bears in further which causes his inside wheel to make contact with the right hind leg of #1. At that point, #1 was maintaining his path and not at fault. #5 Traceur Hanover (Sylvain Filion) was advancing on the inside and forced to check due to the interference to his outside. As per AGCO Rule 22.05.01(a), #2 East End did bear in and cause interference to #1 and #5. As a result, #2 finished 1<sup>st</sup> and was placed 3<sup>rd</sup> (behind #1 Sports Column) for interference.

Race 10 – Inquiry – Reviewed racing in the stretch between #1 Evenwood Sonofagun (Bob McClure) and #4 Matticulous GB (Sylvain Filion). The front tower video shows #4 is sitting second and angles to move out while #1 is to his outside. #4 does not have clearance and puts a wheel under #1, impeding the progress of #1. #3 Always A Hotshot (Jonathan Drury) also suffered interference by being forced to change course. As per AGCO Rule 22.05.01(a)(h), #4 Matticulous GB did change course and hook wheels with #1. As a result, #4 finished 1<sup>st</sup> and was placed 5<sup>th</sup> (behind #1 Evenwood Sonofagun) for interference. Judges will follow up with Filion on Monday.
