Notification of a certificate of positive analysis for Class II, Capsaicin Horse: Ghost Island, finished 4th Trainer: Steven Owens Owner: Empress Stable Ruling #TB 1046045 generated, Ghost Island placed on Stewards list for 15 days, July 30-August 13, 2020. Trainer Steve Owens and Race Secretary notified of horse suspension.

As a result of horses shipping from the United States, racing and staying with a Canadian trainer will now have the trainer here listed as a sub-trainer. Due to shipping costs and CBSA restrictions on persons entering Canada it was determined that this temporary solution will suffice for the time being. The Trainer will determine who is responsible for entering horses to race and inform the Stewards.

Jockey Jason Hoyte issued a monetary penalty of \$100.00 for failing to conduct his business in a proper manner. Mr. Hoyte handles his own riding engagements and failed to leave his calls with the race office on July 28, 2020. TB ruling #1046167.

Race 4, #7 Forest At Dawn off a step slow, #9 Victorian Moon broke quick, bore out and quickly corrected by Contreras, rest good

Race 5, Inner Turf, #6 lugged out into far turn, spoke with J. Crawford to take a better hold as it appeared his horse drifted out, spoke with D. Fukumoto to be aware that when he pulls the crop through from left to right to ensure he gives a stride prior to making contact with mount. Rest ok
