## Backstretch:

An error in the Senior Steward report on July 30, 2020 report regarding information on a claim submitted for the 8th race. The successful ownership of the claimant for the #8 horse, Classy n' Silent, should read as Five Diamonds Racing and not Five Diamonds Racing Stable and Shana Lopez. Apologies for any misconceptions.

Jockey Patrick Husbands excused from the 5th race mount today, his Agent did not accept a call for the mount. Did call the Stewards on Wednesday July 29, 2020

Race Secretary Scott Lane informed us that there was a Race Office error in the split maiden optional claimer 4th race on Saturday August 1, 2020. The horse Beat the Rush, trained by Nick Nosowenko did not participate in the draw of entries as it was a part of same owner/trainer entry and was placed on the also eligible list. Horse should have been part of the draw for the body of race. Horse has been added to the field on the outside post 11 and the horse Bearakontie, trained by M. DePaulo, will be added to the also eligible list as first to draw in upon any scratches in the body of the race. Will be announced to the wagering public.

### Film Reviews:

Race 8, July 30, 2020. Jockey Corey Jordan, appeared to use his crop in an excessive manner, video inconclusive, no penalty assessed.

Race 7, July 30, 2020. Jockey Darryll Holland, I. Driedger as rep. Mr. Holland did admit to bringing crop through to his left hand in the upward position and did make contact with his mount, he did quickly make the correction. He intimated that he is new to the riding colony here in Ontario and is trying very hard to adjust to the change. We took this into consideration and issued a caution.

### Races:

64 entries

Race 1, #5 Mia's Extortionist was fractious in gate prior to start, race clear. #4 Deputy of Egbert was reported by the Official Veterinarian as having an episode of epistaxis.

Race 2, #7 Bachelor Pad popped up at start and was slow, #1 Stormy Egbert lugged out around far turn. Rest ok.

Race 3, #3 Cigarillo was fractious and reared in the gate, Official Veterinarian assessed the horse#2 Tara Empire was slow at the start and stumbled thereafter, rest ok

Race 4, clear

Race 5, #5 Royal Fanfare broke away from post parade with Hernandez with his feet out of the irons and ran off quickly within the course for a half mile, is a Steward scratch. #6 Flashy Signature dwelt badly at start, did receive a fair start. #8 Music Tribute unseated K. Nicholls behind the gate and was loaded into the starting gate without him.

Race 6, reviewed top of stretch regarding #3 D's Ben, L. Salles, appeared to check as it was inconclusive as to #2 inside come out or #5 outside may have pinched in, spoke with Salles, he said that it did get tight but he was out of horse at that point. No violations, rest good.

Race 7, Inner Turf, clear

Race 8, Jockey claim of foul #7 Stein, 6<sup>th</sup> , #10 Lermyte, 3<sup>rd</sup> on #9, Civaci, 1st on far turn,and #4 Salles , 4<sup>th</sup> on #9 Civaci, 1<sup>st</sup>. stretch. Upon review of various camera angles the #7 does check mid-turn but the film is inconclusive. #7 and #10 on #9 disallowed and #4 on #9 stretch allowed as #9 does come in and forcing #4 to check, #9 1<sup>st</sup> placed 4<sup>th</sup> for interference. NOR for Sahin Civaci.
