Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

Spoke with Jockey Agent Paul Souter who represents Sunny Singh, he has agreed to the five day suspension starting August 27-31, 2020.

Spoke with Trainer Julie Mathes on a Change of Performance for the horse Lenches Gimme, finished first in yesterdays' 2nd race. There were a few changes from the two previous starts, a rider change, Veterinarian work done on the teeth, and addition of a tongue tie yesterday. Mrs. Mathes also stated the filly has really come around physically and mentally in the past two weeks. We accepted her explanation and no further action required.

Trainer Paul LePiane, AGCO inspection report #1038508. Report revealed the use of an unlicensed Veterinarian on a horse in racing in Ontario, a monetary penalty in the amount of \$500.00 was implemented, TB Ruling forth coming and reminded to use only AGCO licensed veterinarians for horses racing in Ontario. Previously held purse earnings from 2nd race July 13, 2020 now released.

Jockeys Bradley Wilson and Carl Defreitas excused from their respective mounts today. Jockey Sharyn Nicole Alderson entered into the concussion protocol as a result of an accident in the 8th race August 10, 2020. Ruling # 1055848

Call from Owner Radcliffe Siddo, voiced concerns over scratches of his horses in racing by the Official Veterinarian the past two days, we asked that he speak with the Veterinarians of his concerns.

Race 1, #2 Alert Kitten lacked room to the inside top of stretch, rest ok

Race 2, #6 Quality Brew broke outwardly, compromising its own start, into the hind end of the #7 Ratface Macdougall which eased through the stretch, Jockey Michelle Rainford cautioned on urging left handed when moving laterally to the right. Rest ok

Race 3, Off turf, Thomas F. Moran Stakes, clear

Race 4, clear

Race 5, Off Turf, #5 Soup Du Jour bore in at start, #1 Party Dress lugged out around far turn, rest ok

Race 7, Molson Cup, clear, #1 Gypsy Jazz eased around far turn and was outdistanced

Race 8, Bob Summers Memeorial Cup, #1 Drena's Bullet bore out at start, rest good

Race 9, reviewed the run around the far turn regarding #4 Charlie's Game, P. Mailhot, was in between horses at the 5/16 and appeared to stumble, rest ok
