**Race 1:** All Clear.

**Race 2:** All Clear.

**Race 3:** Judges Inquiry: #4 Farmerstrikesfame (Guy Gagnon) drifts out twice in the stretch onto #6 Letshaveonemore (Murray Brethour) causing interference to #6. #4 Farmerstrikesfame finished 4<sup>th</sup> placed 5<sup>th</sup>. #6 Letshaveonemore finished 5<sup>th</sup> placed 4<sup>th</sup>. No penalty to driver Gagnon as horse was having steering issues.

**Race 4:** All Clear.

**Race 5:** Official warning to Carman Hie regarding urging using more than wrist action.

**Race 6:** Recall charged to #2 P L Notorious (Darryl Thiessen) as the horse suffered broken equipment. (girth)

Judges Inquiry: #2 P L Notorious makes a break before the start and is outside the fair start pole causing a pari mutual refund. #2 P L Notorious qualifies for breaks and goes on the list for performance.

**Race 7:** Drew Neill was in violation of AGCO Rule 22.23.03(b) regarding urging using more than acceptable wrist action while driving #1 First Car. This is his second offence resulting in a five-day driving suspension (September 5,6,7,8,9/2020.) and a monetary penalty of \$300.

**Race 8:** Dan LeBlonc was in violation of AGCO Rule 22.23.03(b) regarding using more than acceptable wrist action while driving #1 Outlawdancwthedevl. This is his first offence resulting in three day driving suspension (August 27,28,29/2020.) and a monetary penalty of \$200.

**Race 9:** Delay of the post parade due to rain. Track is now rated sloppy with a variant of 1 second.

Reviewed racing before the half between #3 Ynothos (Isaac Waxman) and #7 Ldl Gem (Nick Boyd). Interference given to #3 Ldl Gem, no placings needed.
