Attended backstretch, provided Trainer Darwin Banach with documentation for the TCO2 overage of Devil Magic.

TB Ruling #1065332 Devil Magic placed on Stewards list for 30 days, ineligible August 30 through September 29, 2020.

Call from Race Secretary Scott Lane, Trainer Rene Kierans entered Charles Street into a race that did not fill and was called off, there was some discrepancy as to the recording of the conversation as to her request to have the horse if'd into another race that had filled. After review of the recording and determination she did ask to be moved to the other race, the horse was added to the outside post of the 4<sup>th</sup> race Monday September 7, 2020 as per rule 6.39

Race 5, #10 Totally Perfect bore out at start and #9 Conquest Rapiduno bore in, #3 Savvy's Sister, K. Nicholls made it tight for #4 Cheeky Pint 1/8 pole on the inside, #4 does get through to finish 2<sup>nd</sup>, rest ok.

Race 6, #2 Bore out badly at start, compromising a few, #3 D's Soul was a step slow #2 finished 6<sup>th</sup>, Jockey claim of foul, #6 Storm Gauge, D. Moran 2<sup>nd</sup> on #8 Grateful Praise K.
