Pierre Malhot Violation of AGCO rules 16.05 A+B.

Following the running of Race #9 at Fort Erie on Sept 1 2020 when riding Lewnskyswildaffair. Mr Mailhot was found to be in violation for disturbing the peace and did fail to conduct himself in a professional manner towards another participant. Monetary penalty assessed is \$100. Ruling #1066712.

Brian Chevne Violation of AGCO rules 16.05 A+B.

Following the running of Race #9 at Fort Erie on Sept 1 2020 when riding Macol. Mr Cheyne was found to be in violation for disturbing the peace and did fail to conduct himself in a professional manner towards another participant.

Monetary penalty assessed is \$100. Ruling # 1066724

The horse Phantom Sky did bleed after a gallop here on Sept 5 2020. The horse was added to the Vets list.

Stewards scratch Race 2 the horse Due North. There were no ownership papers in the office to allow the horse to race. We spoke with Trainer C. Bennet who said he tried to get them but failed.
