The horse was "successful saint" finished 1st

Drug was Acepromazine and its metabolite 2-(1-Hydroxyethyl promazine)

The panel did speak with Clarke and copies of the tag and certificate was sent to him.

The horse successful saint was declared ineligible to race in Ontario for a period of 15 days, Sept 28 2020 to Oct 12 2020. Ruling # 107223. A copy of the ruling was also sent to Clarke.

Trainer Joe Humber was found to be in the possession of a hypodermic needle in the backstretch of Fort Erie on Sept 28 2020. Violation of AGCO rule 15.02.01. Monetary penalty of \$200. Ruling #1079389

Groom Tess Passero was also found to be in the possession of a hypodermic needle in the backstretch of Fort Erie on Sept 28 2020. Violation of AGCO rule 15.02.01. Monetary penalty of \$200. Ruling #1079405.

Crawford said he did drift out to Nicholls and that he didn't feel that #3 was able to go by him.
