Requirement

Applicants for a new licence or licence renewal under the *Liquor Licence and Control Act, 2019* (“LLCA”) are expected to meet their Ontario tax obligations and certain Federal tax obligations. Applicants must attest that they have verified their tax compliance status with the Ministry of Finance and are compliant with certain tax obligations before the Registrar can issue or renew a licence under the LLCA. Making a false attestation may result in your application for a licence and/or your licence renewal being at risk of refusal, or your licence being subject to regulatory action.
