- Early Veterinary scratch (sick) of IF THE CROWN FITS (David Snowden trainer) from the fourth race; this horse is entered on the short term (seven days) Veterinarian's list.
- In the seventh race #1 WHEELYGOODRINKER was entered with hopples but not listed as such on the program; change announced to the public.
- Early Judges scratches (other) of DIABLO CREEK in the first race and HEIDES WATCHING in the fourth race (Edward Peconi jr. trains both).

- Doug Brown excused from one drive.
- 1. The #7 LAYDEE FREIGHT (Doug Hie) suffered broken equipment (knee boots) after the start and finished with broken equipment. Clear.

Inquiry and driver's objection concerning possible interference by #4 GHOST LIGHT (Loic Gueriel) who finished first to #1 ACEFORTYFOUR RIO (John Thomson) who finished third; after reviewing the race video and speaking with both drivers (Mr. Thomson stated he was forced to grab his horse when #4 went off stride) it was determined that the #4 made a break after the 3/4 mile pole and did cause interference to #1 while off stride; #4 finished first placed third (AGCO rule 22.09).
