Mr. Mcnair was notified this evening and will be in to receive his paperwork tomorrow.

R1 – All clear.

R2 – #4 Myfriendjose (Trevor Henry), (finished seventh) was placed on the Judges list for two consecutive breaks in a row on a fast track and must qualify.

R3 – All clear.

R4 – #5 Karens Dream fell before the race and was scratched by the Judges. After this race Driver Trevor Henry was excused from the rest of his drives this evening.

R5 – #5 Zorgwijk Ventura (Bob McClure), (finished seventh and was placed eighth) made a break for twenty-five strides or more, finished seventh and was placed eighth.

R6 – All clear.

R7 – Recall on #4 Craigieburn (Louis-Phillipe Roy). The horse was not turned.

R8 – Recall on #1 Hungry Hill (Doug Mcnair).

- Judges' inquiry, reviewed racing coming to the wire between #1 Hungry Hill (Doug Mcnair), (finished second and was placed third) and #3 Ma Isabelle (Sylvain Filion), (finished third and was placed second). #1 is visibly bearing outward and drifts out to the #3 causing the #3 to lose momentum. #1 finished second and was placed third for causing interference to #3 while coming to the wire. No film review is required for Driver Doug Mcnair as the #1 was visibly bearing out.

R9 – All clear.

R10 – Judges inquiry, reviewed racing after the three-quarters. #8 Royal JK (Tyler Borth), (finished ninth). The #8 is on the front end and is stopping badly causing confusion to the trailing horses. Interference charted to all horses except for #7 and #8. No placings were required.
