

Races 4 and 8 were taken off the turf today.

Film Reviews:

None. Stewards did speak with new Apprentice Jockey Matthew Dennis, does not carry a whip and to concentrate on steering.

Races:

58 Entries

Race 1, All clear. Jockey Ismael Mosqueira cited for an urging violation, raising hand above shoulder height through the stretch, issued a monetary penalty of \$200.00 TB Ruling #2693350.

Race 2, #3 Stormy Soul, MarkLee Buchanan, 3rd, popped up at start. Rest ok.

Race 3, #3 Armaline, P. Mailhot, 6th, stumbled start, #2 Miss D's Pride, C. Husbands, 5th, taken in hand after the start as the room diminished, rest ok

Race 4, Off turf, #2 Quarky, J. Crawford, 4th, broke awkwardly, rest ok

Race 5, #6 Lea's Sunshine, Alexis Sanchez, 8th, broke through the gate prior to the starter releasing the field, was corralled and re loaded without incident, Race all clear

Race 6, Jockey claim of foul, #6 A. Vandermeersch, 6th, on #4, P. Mailhot, 1st, and #2, J. Crawford, 5th, on #4 and #1, MarkLee, Buchanan, 2nd, top of stretch. Upon review of the front tower, upper pan and apex camera angles, #4 is up on the outside with #6 inside and #2 inside of that one with #1 on the rail, #1 angles out for clear running room around the #5 K. Johnson, as he moves out it tightens for the outside horses and #6 is forced over heels. #1 was considered to have caused the issue and was subsequently disqualified 2nd placed 6th. Race 7, #5, Getting Ahead, K. Johnson, 6th, stumbled start. #7 Speedy Johnny, bore in start. Rest ok.

Race 8, Off turf, #2, You See Me, J. Crawford, 4th, slow at start. Reviewed stretch run #3, Screen Legend, E. Zenteno, 5^{th,} and #2 J. Crawford mid stretch, upon review #3 appears to be tiring and drifts inside to #2, Zenteno does pull off as #2 is forced to steady, no violations.
