Video review of yesterdays fourth race involving Fraser Aebly and Kazushi Kimura. Kazushi drifts out through the stretch and in front of Fraser who then clips the heels of Kazushi's horse. This almost unseats Mr. Aebley but he is able to regain his position in the saddle. Kazushi said he didn't know Mr. Aebly was there and also said his horse shied from the maintenance people in the infield. Faser said he had his lane when Kazushi drifted into his path, yelled then clipped the heels of Kazushi's horse. After review, Mr. Kimura was issued a three day riding suspension, days to be determined.
