

Race 1 – Jockey Claim of Foul (COF) by Skye Chernetz aboard #1 "Stormin Dave" against #6 "Jay Bird" ridden by Fraser Aebly for interference turning in the backstretch. Skye said he slammed me into the fence, my horse lost all momentum, took me out of the race. Fraser said his horse was lugging in hard with him and when they turned down the back stretch and my horse changed leads, we went in and brushed the inside horse. Did my best to correct as quick as I could. After review, the COF was disallowed.

Second COF by Jockey Austin Adams aboard #2 "Umneyaat" against #5 "Might Bee Speedy" ridden by Ryan Munger for interference during the stretch run. Ryan said he had pressure from the outside but didn't feel he impeded anyone. Austin said he had a clear lane and had to take up a bit because of outside pressure. After review, the COF was disallowed.
