Stewards Inquiry into incident at the 3/16th pole involving #3 "Friendly Ghost" ridden by Justin Stein, #6 "Rapid Grey" with Sahin Civaci and #7 "Summer Buck" ridden by Kazushi Kimura. Sahin said his horse was stopping quickly and there was a little jostling but I had no problem. Kazushi said he felt a little bump from the three horse but in was nothing much. Justin explained he went

through very quickly and the three horse came into him slightly. After review, no change was made to the order of finish.

Claim of Foul (COF) by Kazushi Kimura aboard #6 "Kokomo" against #5 "Stitches" ridden by Eswan for interference in late stretch. Kazushi said the outside horse was lugging in on him and my two year old was a bit intimidated, finished strong, may have cost me the win. Eswan said his horse was lugging in the whole race and had Kazushi to my inside through the lane but felt I left him room, never bothered him. After review the COF was disallowed, no change.
